#### News:

On October 22, 2019, a Monroe County Court hearing was held regarding a member who claimed that the PFSC was an invalid organization and therefore no dues and assessments were owed. The Magisterial District Judge ruled in favor of PFSC, and awarded us back dues, court fees, and attorney fees. This decision resolved a long-standing challenge regarding PFSC dues and assessments.

## Open Board Meeting Nov. 2, 2019.

The discussions included working with the PFSC lawyer to update our Bylaws, and to develop procedures to fine the illegal use of the dumpsters starting in 2021. Our Resale Certificate and Transfer Fee was increased to \$350, bringing it more in-line with other communities.

## **Selling Homes and Property:**

By Pennsylvania Law, anyone selling a property needs to contact the PFSC Office to obtain: a Resale Certificate stating the dues amount; a copy of our Projected Budget; and whether dues and assessments are up to date. A Dues & Assessments invoice will be provided if needed. The re-sale and transfer fee is \$350.00, payable at time of closing. Realtors are aware of this, and should be notified about our specific details.

No short-term rentals are allowed; the reason is to reduce noise and commotion in our family-oriented community.
